Every shareholder has the right to make nominations for the election of the Supervisory Board .

Reasons given:

Many shareholders are disappointed that shareholder protectors such as SdK and DSW are unable to assert themselves with hybrid annual general meetings and are being given the runaround by companies The reasons repeatedly put forward by meeting chairs and management boards that hybrid annual general meetings are too expensive are unfounded. To this end, we propose a very simple and straightforward counter-financing solution. To reduce the excessive remuneration paid to management and supervisory board members by the costs of hybrid annual general meetings.

Board members repeatedly treat themselves to 20 to 50 times more remuneration than our Federal Chancellor Olaf Scholz receives.
