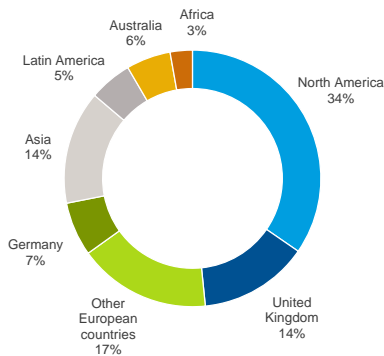
Overview

The Group's German business is written by the subsidiary E+S Rück.

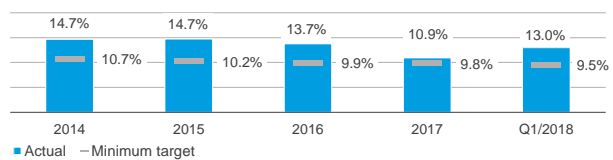
Our vision: Creating value through reinsurance

Gross written premium Group (as of 31 Dec 2017)

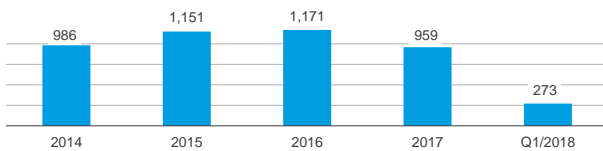


Return on equity



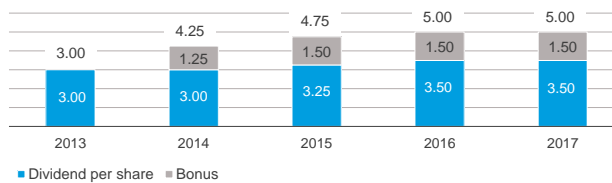
Group net income

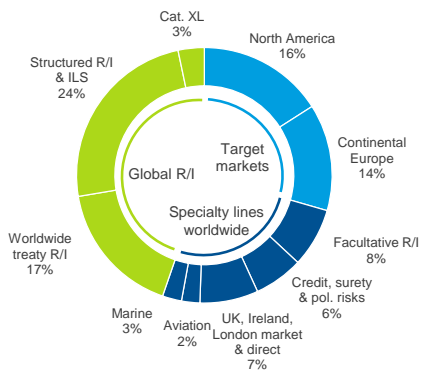

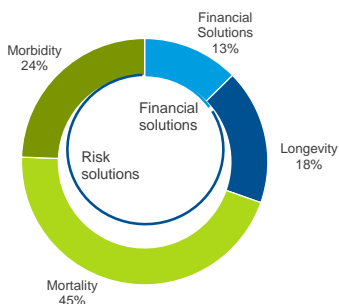
